<b>PROMOTOR</b>	The Government of Riau Island Province, Indonesia
<b>NATIONAL FEDERATION</b>	Indonesian National Volleyball Federation
<b>VENUE</b>	TURI BEACH RESORT, Nongsa Batam, Indonesia
<b>EVENT OFFICE</b>	TURI BEACH RESORT, Nongsa Batam, Indonesia
<b>COMPETITION SCHEDULE</b>	Competition format will be in accordance with the format applied by Asian Beach Volleyball Council
<b>COMPETITION FORMAT</b>	<p>Country entry numbers: Maximum of 2 Men's and 2 Women's Teams per each National Federation, only host National Federation can enter a maximum of 3 Men's and 3 Women's Teams. The AVC shall determine the final quota in according with AVC ranking systems.</p> <p>The competition format shall be Pool play then single elimination. The competition shall last 4 days with organizers providing 1 centre court, 2 other match courts and 1 warm up court.</p>
<b>PRIZE MONEY</b>	US\$ 15.000 prize money (for Men and Women) to be paid to each event by the organizer to main draw teams as per following breakdown & upon conclusion of the event :

Note: Any prize money not utilized will be reallocated pro rata to all teams.

<b>PRELIMINARY INQUIRY</b>	Players must attend the Preliminary Inquiry and present their uniforms and official forms (player's commitment, health certificate) during the inquiry.
<b>&amp; TECHNICAL MEETING</b>	Players must also attend the General Technical Meeting(s). Draws will be made during the meeting; seeding and detail information on the competition will be distributed to players during the meeting.
<b>UNIFORMS</b>	Uniforms will be checked during the Preliminary Inquiry. Players of the same team must wear the same colour and style of shorts. The display of player's sponsor's logos on shorts and accessories is free as long as it complies with FIVB and AVC advertising regulations.
<b>RULES OF THE GAME / BALL</b>	As per FIVB Rules of the Game (2010 edition). The ball shall be the latest available Mikasa.
<b>FORFEIT</b>	Each NF is responsible for informing immediately both the AVC and Organizers in case of forfeit of an enrolled team.
<b>AVC OFFICIALS</b>	The AVC will appoint 2 Delegates (1 Technical and 1 Refereeing) and 3 Neutral Referees.
<b>ENTRY, SEEDING AND WITHDRAWAL</b>	Seeding and Entry Regulations and Withdrawal: in accordance with the decisions of the AVC Beach Volleyball Council.
<b>COACHING</b>	Coaches must be approved by the AVC Delegate and desirably be accredited by the FIVB as a minimum.
<b>MEDICAL CONTROLS</b>	The AVC reserves the right to perform random medical controls, as per FIVB rules and regulations.
<b>PLAYERS ELIGIBILITY</b>	Only players, who have sent to the AVC and the Organizer the required forms, will be considered eligible to take part in this event in Batam, Indonesia.
<b>INSURANCE</b>	It is mandatory that all athletes have their own liability and medical insurance. The AVC and the Organizer will not be held responsible for any medical expenses incurred while competing in a tournament. Basic medical facilities will be available.
<b>TRANSPORTATION</b>	<p>Players are responsible for their own international and domestic airfare and for any airport taxes, visa expenses, insurance etc from Changi Airport to Tanah Merah Ferry Terminal. Players are requested to apply early enough for their entry visas, whenever needed. An invitation letter will be sent by the organizers if required.</p> <p>All participants are suggested to take route from Singapore Changi Airport and used a cab to Tanah Merah Ferry Terminal and go through Nongsa Ferry Terminal Batam. It takes only 45 minutes (see map below)</p> <p>The Organizer will arrange and be responsible for transportation from Nongsa Ferry terminal to hotel and from hotel to venue.</p>

**BOARD & LODGING**

The promoter will cover the board & lodging costs of all players of the participating teams from 2 days before the start of the tournament. Any other team members have to pay US\$ 50 for twin room and US\$ 70 for single room (Three meals and local transportation are included) during Preliminary Enquiry.

All participants are however personally responsible for all and any extras at the hotel such as mini bar, phone calls, laundry, etc that must be paid at checkout.
