RULES OF THE GAME & OFFICIAL BALL:	As FIVB's Rules																									
Officials and Referees	AVC will nominate 1 Technical Supervisor, 1 Refereeing Delegate, and Neutral Referees; the Organizer will assign the rest referees.																									
TRANSPORTATION:	Transportation: Players are responsible for their own international airfare and for any airport taxes or visa expenses to and from Noi Bai, Hanoi Airport. Players are requested to apply early enough for their entry visas, whenever needed. The organiser will arrange and be responsible for all local transportation for all participants and referees from the airport to Ha Long, from Ha Long to Noi Bai on the departure day.																									

BOARD & LODGING:	<p>The promoter will cover the board & lodging costs of all players of the participating teams from officials from the evening of 24th April to the breakfast of 30th April.</p> <p>The Organizer will not cover any board and lodging expenses for the coaches, NF head of delegation, athletes' parents or any other people accompanying the players. Any other team members have to pay US\$ 50 for twin room and US\$ 70 for single room (Three meals and local transportation are included) during Preliminary Enquiry.</p> <p>All participants are responsible for all and any extras at the hotel such as mini bar, phone calls, laundry, etc that must be paid at checkout.</p>
Medical Controls	<p>The Organizer reserves the right to conduct random medical controls as per FIVB rules and regulations.</p>
ENTRY:	<p>The CONFIRMATION OF PARTICIPATION form must be sent to the Volleyball Federation of Vietnam before, but not later than March 22, 2010.</p>
PRELIMINARY INQUIRY & TECHNICAL MEETING:	<p>Players must attend the Preliminary Inquiry and present their uniforms. Players must also attend the General Technical Meeting. Draws will be made during the meeting; seeding and detail information on the competition will be distributed to players during the meeting.</p>
Forfeit	<p>The participating NFs have the responsibility to timely inform AVC and the Organizer if there is a forfeit of their teams from the 2010 Tuan Chau – Ha Long Asian Women's Beach Volleyball Tournament.</p>
