The display of players' sponsors' logos on shorts and accessories is free as long as it complies with FIVB/AVC advertising regulations.  Organisers will not provide playing tank tops and/or tops for the players. Please bring at least two sets of uniforms in contracting colors (one set in dark color and the other in light color). Each set of uniform has to display the shirt number (i.e. No. 1 & No. 2) as well as the country code or country flag.	
RULES OF THE GAME & COURT SIZE:	As per FIVB's Rules of the Game	
FORFEIT & WITHDRAWAL:	The participating NFs have the responsibility to timely inform AVC and the Organizer in case of forfeit of an enrolled team. Such withdrawal shall be sent to AVC and the Organizer at least 3 days before tourrnament.	
COACH:	Coaching is not allowed during the match.	
Medical Controls	The Organizer reserves the right to conduct random medical controls as per FIVB rules and regulations.	
INSURANCE	It is manadatory that all athletes have their own liability and medical insurance.	
TRANSPORTATION:	Transportation:  Players are responsible for their own international/domestic airfare and for any airport taxes or visa expenses to and from Tan Son Nhat, Ho  Chi Minh City Airport.  Players are requested to apply early enough for their entry visas, whenever needed.  The organiser will arrange and be responsible for all local transportation for all participants from the airport to VUNG TAU (2,5 hours), from VUNG TAU to Tan Son Nhat ariport on the departure day (2,5 hours).	
BOARD & LODGING:	The Organizer will cover the board & lodging costs of all players of the participating teams from lunch of 26 <sup>th</sup> October to the breakfast of October 31st.  All the other members (including coaches, team manager) have to US\$ 60 for twin room and US\$ 80 for single room (Three meals and local transportation are included) during Preliminary Enquiry.  All participants are responsible for all and any extras at the hotel such as mini bar, phone calls, laundry, etc that must be paid at checkout.
